## ECSA JAPAN NEW CHAIR

New president of ECSA Japan since March 2015 is Prof. Koji Fukuda of Waseda University (Tokyo). Fokuda succeeds Takao Suami, Professor of Law at Waseda Law School.

At Waseda University, Prof. Fukuda is currently a Professor at the Graduate School of Political Science and Economics. He is also director of the Waseda Institute for EU Studies and Representative of EUIJ Waseda (European Union Institutes in Japan).

He graduated from Waseda University, gained a doctorate from Doshisha University Graduate School, served as a Visiting Researcher at the College of Europe in Brugge (1992-93), and then served as a Professor at the Faculty of Law at Komazawa University. His areas of specialization include Global Governance and International Public Policy, International Public Administration, European Public Policy and European integration.

# CHANGES IN THE EUROPEAN COMMISSION

As ECSA World president Enrique Banús announced to the board few days ago, some changes had taken place in the European Commission Direction responsible for the Jean Monnet Programme and also for ECSA. Firstly, Harald Hartung is not anymore responsible for Jean Monnet but for youth policy and the youth programme. Claire Morel is Acting Head of Unit, and on that way, succeeder of Hartung. Morel was previously Deputy Head of Unit of the International Cooperation Unit. Otherwise, Vito Borrelli is now Head of Sector, more specifically, he is in charge of the design, implementation and follow-up of the programme. He is presently involved in the preparation of the next phase of the programme (2014 onwards).

According to the Organizational Chart, the Jean Monnet Unit is located in Direction B of DG Education and Culture. Acting Director is Adam Tyson (succeeding Jordi Curiel).

General Director (since 2011) is Xavier Prats Monné.
